- h) Ukiah Adult School-signal vine-two way comm from students/users, send files,
  - 1. Ukiah Adult School plans to apply for one time monies to pilot the use of a program called SignalVine.
  - Allows for two way communication with students
  - Files and notices of different formats may be sent to recipients
  - SignalVine with update the contact list as often as we submit the information to them
  - the cost is a one time setup fee of \$1,500, and \$7,000 annually
  - Kathy is willing to receive the calls and forward the callers to the appropriate consortium members this year as part of our pilot
    - 2) Ukiah Adult School is gathering information with the plan of piloting advertisements through the MVN (ads at the DMV).
  - The 30 second ad would be displayed 4 times an hour.
  - The cost is \$325/month. \$3,900 a year.
