 - i. SCT Non-credit Certificate Program:
 - Noel: slideshow for construction trade
 - Noncredit SCT Certificate offered in Lake County, six BUILD workers fulfilled their training; This is the second time the Non-credit SCT Certificate program was offered in Lake County., two graduates from the previous class, current crew and previous alumni
 - Michael Ross, SCT part-time instructor; severa students were able to complete all courses to get certificate; 7 certificates
 - 5 of 7 have secured jobs.
 - Student success, class was full, students learned electric wiring, roofing, framing while building a tool shed.
 - Collaboration with college SCT, NCO-BUILD project and MLACE.
 - ii. Fiesta Events at Lake and Fort Bragg (funded by MLACE one-time funds)
 - Amanda: about 200 community members for events, families, encourage to register for college classes.
 - For Fall: will offer creative writing, weight training courses for older adults; \$12 for noncredit classes





f. Mendocino County Office of Education

- Phlebotomy completed with national exams, dental ends next week, already recruiting for both of those programs.
- Will start recruitment for M.A. program.
- Programs are in demand and meet the needs of the community.
- Euline shared that she stopped by Career Hub and gave medical booklets to Joel to share those medical health care programs to inquirers. We share information with Suzanne Hewitt and she passes these on to candidates that apply for RN program that don't make it to RN program selection. This is a great options for many students.

g. Ukiah

- 40 plus High School diploma graduates
- INFO: ED code 41976: allows district to fund adult and family literacy efforts if its written into the LCAP

- Reduction of high school diploma credits was approved; credits will go down to 140 to remove one year
