- a. Member agency gives enrollment/TE updates, activities, wins, challenges, concerns, etc.
 - **Anderson Valley** We have seen an increase in student attendance. We believe attendance has increased because of the extra night we are offering for ESL.
 - We tried an experiment of offering 2 levels of ESL over the summer.
 - We have not established the High School Equivalency program in Anderson Valley, due to not being able to find a teacher and allocate our own resources to make this happen.
 - Fort Bragg- We have the high school diploma, ESL, and Citizenship programs running.
 - We have about 12 enrollments in the diploma program.
 - We recently introduced the bright thinkers curriculum.
 - Ukiah Adult School-We are losing the LVN program to the college, where it will be given.
 - In 21-22 we see few enrollments because of Covid.
 - We almost doubled our graduation rate because we really targeted people who had been in our program for more than 2 years.
 - We started a new independent study program and we got most students graduated, so we're continuing that this year.
 - Last year, we graduated 81 students which is about double the amount that we usually have.
 - We are pre-post testing for ESL only, not HSD.
 - Our current programs are: HSD, Citizenship, GED, Jail Program, and ESL.
 - Willits- Our enrollment has been dwindling. As long as their needs are being met, that's what is important.
 - One of the reasons that our registration and attendance are low is because Leggett also has their own HSD program.
 - Our HSD attainment has increased steadily the last 2 school years.
 - We have been approved to house Citizenship and ESL programs but since we go through our carry over funds, we do not know how we are going to pay for that.
